

Important updates to disclosure brochures for *Ameriprise*[®] Managed Accounts

The Managed Accounts Client Disclosure Brochure and the Managed Accounts and Financial Planning Service Disclosure Brochure (collectively, "Disclosure Brochures") were updated March 2023. The following is a summary of the material changes to the Disclosure Brochures since the last annual update of March 2022, many of which have already been communicated to you. Material changes that are reflected for the first time in the 2023 annual update are marked with an asterisk.

 a revised description of the investment advisory referral arrangements and compensation
 agreements (including examples of the types of compensation) that Ameriprise Financial
 Services maintains with "Promoters."
- The "Supervision" section of the Form ADV: Brochure Supplement for each of Al Saffert, Michael Costley, Paul Mumma, Paramita Sarkar, Nicole Bjugan and Thad Ingersoll was updated to change the supervisor from (i) Greg Nordmeyer, Executive Vice President, Wealth Management Products & Solutions to Matthew Huss, Senior Vice President and General Manager Wealth Management Products & Solutions, effective June 2022; and *(ii) from Matthew Huss to Sandra Bolton, Executive Vice President, Head of Wealth Management Solutions, effective March 2023.
